

Ø	The Company has a Directors' Share Plan to allow Directors to salary sacrifice part of their director fees into shares (subject to Shareholder approval each year). The Company also has a Performance Rights and Option Plan. The Executive Directors may also salary sacrifice into Options subject to Shareholder approval.  Clearance from the Board must be received prior to entering into any financing transactions with the company's shares. This prohibition is contained in the Company's Securities Trading Policy, a copy of which is available on the Company's website.
