### Bank Loans - Austria

ADX Group (through its subsidiary, ADX VIE GmbH) has a loan facility guaranteed by the Austrian state and executed by Volksbank. EUR 120,000 collateral is held in an ADX VIE GmbH account with Volksbank. The facility consists of two parts:

- EUR 500,000, interest-free until 31 July 2022, at which point interest charged at Euribor plus 0.75%, with the rate to be at least 0%; and payback every 6 months, started 30 June 2022 and ends 31 December 2024; and
- EUR 630,000, 1% interest, same payback terms as above.

As at 30 June 2023, repayments totalling EUR 565,000 have been made.
